Agreements and policies 2017-2018 school year (one form per family)

All Elementary and Secondary students who arrive at school before 7:40 am must go to Extended Care in the gym. Elementary and Secondary students not picked up at 2:50 must report to the gym for Extended Care. A parent or other authorized signature is needed to dismiss a student once he/she is signed in during afternoon Extended Care. **Fees will be charged before 7:30 am and after 3:15 pm.** Charges for this service will be placed on your account to be paid monthly.

Release of Liability

_____ I agree to hold harmless, indemnify and release Pleasant View Christian School, their agents and employees and any volunteer from any liability for any injury or damage sustained with the minor while attending School Age Child Care activities.

Medical Emergencies

_____ I hereby authorize Pleasant View Christian School personnel to provide emergency medical care for my child enrolled in the program. In the event that I cannot be reached, I hereby give permission to the physician selected by Pleasant View Christian School personnel to order x-rays, routine tests and treatment for the health of my child. I give permission to the physician selected by PVCS personnel to hospitalize, secure proper treatment for and to order injection(s) and/or anesthesia and/or surgery for my child AFTER all emergency contact attempts have been made.

Behavior Expectations/Demerit Policy

_____ Students are expected to follow all the directions the first time they are given. Keep hands, feet and all objects to self and call others by given names. All school rules will apply. If students fail to follow the rules, they will be given age appropriate consequences. (i.e. time out, demerits) Extended Care staff will communicate with parents should a discipline problem occur. Every effort will be made to work with the students and their parents to solve problems as they arise. If a discipline problem occurs, I will be contacted by the staff member in charge of my child, or by the Director of Preschool/Extended Care. I understand that immediate suspension from Extended Care for one to five days can occur for inappropriate behavior. I am still responsible for fees if my child is suspended. PVCS reserve the right to dismiss any child from our late stay program who is a consistent discipline problem.

Late Pick up

_____ I understand that I will be charged \$5.00 per 10 minutes, or any portion of 10 minutes for my child being picked up after 6:00 pm. **After the second time of being late the fee becomes \$20.00 per 10 minutes.**

Release of Child

_____ I understand that my child will only be released to those contacts listed on my authorized to pick up list. Any changes to that list must be made in writing. **My child must be physically signed out by the authorized person who picks him/her up.** A parenting plan will be required for situations involving paternal rights.

*******Information Acknowledgement**

_____ The extended care fee is \$150.00 per month for (1) student, \$180.00 for (2) in the same family and \$200.00 a month for (3) children. If a child stays only a few hours a month, the charge is \$8.00 per hour for (1) student, \$10.00 per hour for (2) and \$12.00 per hour for (3+). This will only cover before and after school care and not days when school is closed but care is available. Childcare will be available on some days when school is closed for K5-5th grade. Please see the school calendar. The charge is \$30 per full day and \$25 for 11:00 dismissal. This includes lunch and snacks.
